Membership Categories and Application Form

Membership Categories

The Association has seven categories of membership: Full Contracting Member, Full Member Non-Contracting (ATaC or Associate), Labour Supply Member, Associate Member, Corporate Member and Information Service Member. These categories of membership are open to licensed asbestos removal companies, UKAS accredited laboratories, consultants and organisations providing goods or services for the industry, and companies with an interest in the asbestos abatement industry.

Membership is open to overseas companies as well as those within the UK. The stringent entrance requirements and conditions of membership apply in order to satisfy the Association's Governing Council that standards are meticulously maintained. Adherence to a set of Rules of Membership forms part of the membership criteria.

Full Contracting Member

Shall be a company engaged in the removal of asbestos materials and who complies with the conditions of membership.

Example Company Type:

HSE Licenced Asbestos Removal Contractor or Republic of Ireland Asbestos Removal Contractor

Registration Fee: £1,100 +VAT

Annual Membership Fee: £2,500 +VAT

includes £1,300 of credits for ARCA training and fully inclusive of two ARCA site audits.

Full Member Non-Contracting (ATaC)

Shall be a person or company which fulfils the criteria of the Asbestos Testing & Consultancy Division (ATaC).

Example Company Type:

UKAS accredited laboratory for asbestos services

Registration Fee: £100 +VAT

Annual Membership Fee: £1,100 +VAT

Full Member Non-Contracting (Associate)

Shall be a person, company or organisation which fulfils Associate membership status, but who also requires voting rights and the opportunity to stand for election to the Governing Council.

Example Company Type:

Asbestos equipment/services manufacturer/distributor

Registration Fee: £100 +VAT

Annual Membership Fee: £1,100 +VAT

Labour Supply Member

Shall be a company supplying operative labour to the licensed asbestos removal industry.

Example Company Type: Specialist asbestos recruitment agency

Registration Fee: £600 +VAT

Annual Membership Fee: £600 +VAT

Associate Member

Shall be a person, company or organisation that provides an industry related service to Full Contracting Members, but does not qualify for full membership of the Association.

This category of membership is also available for overseas companies (outside of the UK and ROI) who are involved in asbestos removal.

Example Company Type:

Asbestos equipment/services manufacturer/distributor

Registration Fee: £100 +VAT

Annual Membership Fee: £600 +VAT

Corporate Member

Shall be a company or organisation which fulfils the Corporate Membership status, but does not qualify for full or ATaC membership and operates in the following sectors:

- ▶ Building, construction and property e.g. consultancies, architects, building surveyors.
- ▶ Trade Associations with members operating in these sectors

▶ Local Authorities, Housing Associations
Corporate Membership entitles the company to five places per annum on ARCA's leading Asbestos Awareness training course. Attending where appropriate may count towards continuing professional development (CPD) on any CPD schemes which are self-administered.

Registration Fee: £100 +VAT

Annual Membership Fee: £350 +VAT

Information Service Member

Subscribers to the Information Service may be admitted to the membership of this service upon application. This does not entitle them to use the ARCA logo. Example company type: Local Authority, construction contractor, information service provider.

Registration Fee: None

Annual Membership Fee: £195 +VAT

The Application Process

Full Contracting Member

1. Completed application form submitted with supporting documents and fees.
2. Application reviewed
3. References requested
4. Office audit
5. Site audit
6. Once all the above is satisfactory, the application is referred to the Association's Governing Council.
7. If approved, membership on a 12 month probationary basis or if rejected the applicant must wait 6 months before reapplying for membership.

Full Members Non-Contracting (ATaC, Associate), Associate Members and Corporate Members

1. Completed application form submitted with supporting documents and fees.
2. Application reviewed
3. If satisfactory the application is referred to the Association's Governing Council.
4. If approved, membership on a 12 month probationary basis or if rejected the applicant must wait 6 months before reapplying for membership.

Labour Supply Members

1. Completed application form submitted with supporting documents and fees.
2. Application reviewed
3. References requested
4. Office audit
5. Once all the above is satisfactory the application is referred to the Association's Governing Council.
6. If approved, membership on a 12 month probationary basis or if rejected the applicant must wait 6 months before reapplying for membership.
7. Annual office audit prior to renewal.

Information Members

1. Completed application form submitted
2. Once the application is approved, the applicant will be admitted into membership.
